

34. SPRINT BUSINESS ESSENTIALS<sup>SM</sup>

1. Description

Sprint Business Essentials is designed to meet the communications needs of small business customers. This service offers four monthly commitment levels: \$0, \$50, \$150 and \$350. The Dial-1 and toll free interstate rate will be determined by the customer's commitment level. If a customer does not meet their monthly commitment level, they will be charged the difference between their monthly commitment and their total long distance usage.

The \$0 commitment level customer will be assessed a monthly recurring charge (MRC). Additional MRCs will apply to interstate and international toll free service. All customers will incur a non-recurring set-up fee for each line. FONCARD calls will be assessed a per call connection fee. When an operator assists with a call, the applicable per minute rates, call placements charges and surcharges will apply.

A customer who subscribes to this service is required to receive their bill from Sprint.

The business rates for the Presubscribed Line Charge and the Carrier Universal Service Charge will also apply. In addition, other taxes and fees may apply.

2. Interstate Usage Rates

1. Dial-1 and Toll Free

The following rates apply to interstate Dial-1 and switched toll free service. Dial-1 service is available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. Interstate Dial-1 calls may terminate to a state, U.S. possession or territory that is different from the originating location. Dial-1 terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11. Interstate toll free calls may originate in the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11. Interstate toll free calls may terminate to the U.S. Mainland, Hawaii, Puerto Rico, and the U.S. Virgin Islands.
