5. SPRINT PREMIERE

1. Overview

1. Description

Sprint PremiereSM is a service offering for multi-location customers which may include VPN Premiere, Sprint Premiere Toll Free, Switched Digital Service (SDS) Premiere, and Sprint Premiere Toll Free SDS. Sprint Premiere includes communications, invoicing, customer service and network management options. Sprint Premiere offers voice and data connectivity among customer's locations and to Sprint's network for both outbound and inbound communications through a variety of switched and/or dedicated access options. Service is available throughout the United States and the world. For the entire list of international locations see [International Termination Points for Business Communications Services](#). A variety of features, discount options, Targeted Calling Options, Custom Business Options are available with Sprint Premiere.

2. Access Options

Sprint Premiere offers all access options described in Section 3.1 of [Business Communications and Miscellaneous Services](#). These options are available for VPN Premiere, Sprint Premiere Toll Free, SDS Premiere, and Sprint Premiere Toll Free SDS. For the purposes of call rating, both origination and termination, switched access is considered Off-net and dedicated access is considered On-net. See [Sprint Schedule No. 8](#) for all dedicated Local Access Facilities components and rates.

3. Bill Increments

VPN Premiere offers six-second increments with an 18-second minimum for domestic calls. Sprint Premiere Toll Free and Sprint Premiere Toll Free SDS offer six-second increments with an 18-second minimum for domestic and a 30 second minimum for all international calls except for toll free services terminating in Canada, which require an 18 second minimum time requirement per call.

SDS Premiere offers six-second increments with an 18-second minimum for domestic calls and a 30-second minimum for international calls.

4. Call Periods

Different call periods apply for domestic calls and for international calls. The call periods are included with each product's rates in this section and in international rate tables.

5. Dial Plans

In addition to the 1+NPA, 011+IDDD and 1+800 dial plan supported by all origination or termination options, VPN Premiere also supports Custom Network Addresses from all dedicated, FONCARD and from switched locations using 1+700 +7-digit calling.

6. Call Types

1. VPN Premiere and SDS Premiere Call Types

The ability to originate and terminate calls on switched (Off-Net) and dedicated facilities (On-Net) allows calls to rate using the four call types described below. For further information on access methods associated with switched and dedicated access, see Section 3.1.2 of [Business Communications and Miscellaneous Services](#).

1. On-Net to On-Net

A call between two locations originating and terminating over a customer's dedicated access facilities.

2. On-Net to Off-Net

Calling that originates on a customer's dedicated access facility and terminates at any switched access location worldwide.

3. Off-Net to On-Net

Calling that originates at a customer's switched access location or on the public switched network and terminates on a customer's dedicated access facilities.

4. Off-Net to Off-Net

Calling that originates at a customer's switched access location or on the public switched network and terminates at any location worldwide.

2. Sprint Premiere Toll Free Call Types

Sprint Premiere Toll Free has two call types: switched, for calls terminating at switched (off-net) facilities; and dedicated (on-net), for calls terminating on dedicated facilities.

3. Minimum Usage Requirements

1. Account Monthly Minimum Usage Requirement

Sprint Premiere customers have Monthly Minimum Usage Requirements. The requirements are based on interstate, intrastate and international gross monthly usage (dollars) per account for all access types except Dedicated Managed Access. Interstate and international gross monthly usage contributes to the Dedicated Managed Access account monthly minimum. If an account does not meet its monthly minimum usage requirement, the account will be charged the difference between actual usage and the minimum usage requirement. Non-usage charges, including but not limited to surcharges, install charges, and features charges, do not contribute to the minimum usage. Account Monthly Minimum Usage Requirements do not apply to Hotline dedicated access. See [Sprint Premiere Feature Rates](#) for Hotline charges.

2. Hierarchy Minimums

Billing hierarchy minimum requirements apply in conjunction with MVP plans. (See Section 5.4 for MVP information.)

1. Monthly Minimum Usage Requirements

Sprint Premiere billing hierarchies have a monthly gross usage (dollar) requirement. Sprint VPN Premiere, Sprint Premiere Toll Free and SDS Premiere interstate, intrastate and international gross monthly usage (dollars) contributes to the requirement. Account minimums assessed to meet the account minimum requirement are included in the contributory usage. If a hierarchy does not meet its monthly minimum usage requirement, one location in the hierarchy is charged the difference between actual usage and the minimum usage requirement. Non-usage charges, including but not limited to surcharges, install charges and features charges, do not contribute to the minimum usage requirement. New Sprint Premiere customers have a three month (billing-period based) grace period from their MVP start date before these minimums will be applied. If a Monthly Minimum Usage Charge is assessed, the amount charged is not credited towards the Annual Minute Commitment.

2. Hierarchy Annual Minutes Requirements

Sprint Premiere billing hierarchies have an annual minutes of usage requirement based on the MVP option selected. Sprint VPN Premiere, Sprint Premiere Toll Free and SDS Premiere interstate, intrastate and international minutes of use contribute to the requirement. A customer's total annual minutes are calculated based on the MVP start date. A shortfall charge is assessed each year the customer fails to meet the annual minimum commitment. The shortfall charge is billed to one location in the billing hierarchy. The charge is based on the difference between the customer's annual billed minutes of Sprint Premiere usage and the Annual Minimum Minutes required, the difference (shortfall) is then multiplied by the shortfall charge. Annual Minimum Requirement shortfall charges do not contribute to the Monthly Minimum Usage Requirements.

Customers who upgrade from their current MVP option will be given a new MVP start date. 8. Termination With Liability

The customer-specified routing destination and types of calls routed to those destinations are determined based upon the routing logic contained in the Customer-owned and maintained Routing Processor (CRP) located at the customer's premises. The customer is responsible for providing their own routing processor and the routing logic used to respond to inquiries from the Sprint network. Sprint will not be responsible for any errors in call routing caused by the Customer's routing processor decisions and responses to Sprint's SiteRP service inquiries. All toll free numbers with SiteRP routing must utilize Enhanced Routing services.

Use of the SiteRP requires CLEARLINE Digital Data circuits between all Sprint Service Control Points (SCPs) and the CRP using X.25 protocol. In addition to access charges, a non-recurring installation charge and monthly recurring charge (based on monthly usage) will be charged. Normal Sprint Premiere Toll Free usage and feature charges apply. Customers must subscribe to an initial one year SiteRP service period commencing on the first day of the regular billing cycle after SiteRP Toll Free has been installed and activated for the customer and shall remain in effect after the initial term of one (1) year until either party provides ninety (90) days written notice to the other party.
