### 3. SERVICE COMPONENTS AND RATES

#### 1. Local Access Facilities

##### 1. General Description

In order to subscribe to Sprint's Digital Private Line and Sprint's voice products with dedicated access, the subscriber will need to gain entry to Carrier's network by means of a Local Access Facility (such as voice grade facilities or T-1 Access). Such local access facilities will generally be ordered from local telephone companies in the customer's name, by Sprint, as agent. Sprint will bill customer for these facilities.

Any special construction or non-standard charges assessed by the local telephone company supplying the local access will also be the responsibility of the Customer. On occasions when alternative facilities are necessary (those provided in lieu of Carrier-designated access provided facilities), Sprint will charge the customer per the rates and charges set forth in this schedule unless special service arrangements are involved as described in Section 2.13 of the Terms and Conditions for this schedule.

Sprint's scope of work for alternative access facilities may include, but are not limited to, detailed assessment or engineering studies, alternative vendor interface and installation supervision.

If applicable, subscribers will also incur charges associated with additional access components, i.e., central office connection, access coordination fee, special access surcharges and co-location of facilities charge.

Central office connection charges apply in all cases in which a customer wishes to connect to the Sprint network. The applicable charges are determined based on the type of access interconnected, i.e., OCn, T-3, T-1, Dedicated Access Line or Digital Data Access Line.

Access coordination will apply in those cases where Sprint acts as the Customer's agent and orders local access. The applicable charges are determined based on the type of access ordered; i.e., OCn, T-1, Dedicated Access Line or Digital Data Access Line.

1. General Description (Continued)

Co-located Access Facilities are any which do not use local telephone company facilities and are generally limited to connections within a single building structure. That is, Customer premises will be in the same building structure as the Sprint point of presence. If the co-location charge is applicable, Sprint will not charge the Central Office Connection fee, the Access Coordination fee or the Special Access Surcharge.

The Special Access Surcharge of \$36.25 is applicable to each voice grade or data access line provided and is applied in accordance with the National Exchange Carrier Association Schedule No. 5. The Special Access Surcharge will be waived if the customer certifies to Sprint that the circuit is not connected to a Private Branch Exchange (PBX) or other device capable of switching traffic to or from the local exchange.

The following access types are required by service:

Clearline 45 SERVICE: OCn, T-3 Access

Clearline 1.5: OCn, T-1 or T-3 Access

Clearline Fractional 1.5: OCn, T-1 or T-3 Access

Clearline 2.0 Service, Clearline Clear Channel (Offshore and International only): OCn, T-1 access or E-1 Access

Clearline Voiceband: Dedicated Access Line, T-1 or T-3 Access

Clearline Digital Data Services: Digital Data Service (DDS), or T-1 access. DDS Access line availability may be restricted if local access carrier's facilities are not equipped to provide local DDS channels.

Clearline 155 Service: OC3 Access

Clearline 622 Service: OC12 Access

Primary Rate Interface: OCn, T-1 or T-3 Access. Access availability may be limited to a local access carrier's ability to provide PRI.

Total Solution WATS Service - Dedicated Analog Lines (DALs), T-1 Access

Sprint Clarity services - Dedicated Analog Lines (DALs), T-1 or T-3 Access

The charges for local access facilities are outlined by EO CLLI codes in the tables in Attachment 1 of this schedule. In instances where Sprint does not have facilities available in an EO CLLI code, the charge will be listed as "ICB" and will be calculated on an individual case basis. The monthly recurring and non-recurring charges for OCn or T-3 local access facilities will be calculated based on the monthly recurring charges and non-recurring charges of the underlying access provider (See Attachment 1 of this schedule).

For customers desiring to provide their own access ("CPA" Customer Provided Access) in Broadband Metropolitan Area Network (BMAN) markets, it is the customer's responsibility to ensure that all DS1 (T-1) or higher access is BMAN (SONET) compatible.

If necessary, existing CPA interconnections must be reprovisioned to meet the foregoing requirements within 30 days following written notice from Sprint or the service will be disconnected.

Sprint reserves the right to restrict interconnection at either the wire center serving the Sprint POP or the Sprint POP itself.

4. Minimum Service Period

Local access facilities for T1, DS0, and DDS access services are offered with a minimum commitment period of 3 months. Alternative access facilities or local telephone company special construction require minimum commitment periods and are to be defined via contractual agreement. Local access facilities for CLEARLINE 45 Service (T3 access) require a minimum commitment period of one year, unless otherwise defined through a vendor-provided term plan offering (ordered by Sprint on behalf of the customer via a letter of agency from the customer). Any termination liabilities incurred by Sprint as a result of such plans shall be solely the responsibility of the customer.

2. Miscellaneous Services

This section includes miscellaneous services provided in conjunction with Carrier's primary service offerings.

1. Trouble Shooting At Subscriber's Premises

This charge is to cover the cost to Carrier of a visit to subscriber's premises to determine what equipment is the cause of a malfunctioning channel. This charge applies in cases where Carrier identifies the trouble to be caused by subscriber provided equipment and is unrelated to any malfunction of Carrier's service. The charge applies from the time Carrier personnel are dispatched until the problem is identified.

2. Out-of-Hours Work Charge

This charge is to cover the additional costs incurred by the Carrier when performing standard tariffed services outside of normal work hours. This charge applies to each hour expended rounded to the nearest half-hour. It applies in addition to the standard tariff charges for the work requested.

3. Moves and Rearrangements

The subscriber may move locations or order his service arrangement (e.g., tie line, foreign exchange, etc.) changed with or without a move. Rearrangements shall also include adding, changing or deleting circuits or services embedded in a T-1 access facility. It is subscriber's obligation to notify Carrier in writing at least 90 calendar days in advance when a move or rearrangement is to be made. If Carrier is given inadequate notification, Carrier will not be liable for issuing credit for the period between the date subscriber desires the moved or rearranged service and the date the move or rearrangement is actually made for the subscriber's use.

4. Record Change

When a subscriber requests a record change, the subscriber will be billed a non-recurring charge for each record change occurrence. A record change is described as any subscriber-requested change in the permanent records of a subscriber that does not require any physical or technical adjustments to the service, such as a name change or billing address change.
