**SPRINT 7 CENTS ANYTIMESM ADVANTAGE MARKET TEST
(NO LONGER OFFERED CONTINUED)**

- Sprint 7 Cents AnyTime intrastate rates will apply to in-state calls.
- If a customer cancels service, the annual recurring charge will not be prorated on the customer's final invoice.
- All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.
- All call placements charges, connection fees and surcharges apply per call.
- This service is available to residential customers who have selected Sprint as their primary interexchange carrier.
- Dial-1 and Operator state-to-state and international services are available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. FONCARD state-to-state and international service is available from the U.S. Mainland, Alaska, Hawaii, Puerto Rico, the U.S. Virgin Islands, Guam and CNMI.
- State-to-state calls may terminate to the U.S. Mainland, Alaska, Hawaii, Puerto Rico, the U.S. Virgin Islands, Guam and CNMI.
- A customer's phone line may not be classified as a "business", "public" or "semi-public" line. The customer's account may not have more than one residential phone line associated with its account and each household is limited to one Sprint 7 Cents AnyTime Advantage account. A customer must have an individual residential phone line service from Sprint, the local exchange company or mobile service provider presubscribed to Sprint for interstate long distance service.
- The customer's phone line may not be in housing associated with educational institutions.
- The customer may not use this service for commercial use, for connection to the Internet, for other data services (including facsimile transmissions) or for any other use that does not involve a person-to-person conversation or voice message.
- The term usage does not include usage from multi-party conference calls, calls to 900 NPAs, calls to Directory Assistance, FONCARD Service, operator service or inbound toll free service.
- If Sprint determines that the service is not being used for individual residential service, or in any other way violates the restrictions of this service, Sprint may suspend or terminate the customer's service.
- Other surcharges and fees may apply, including (but not limited to) Carrier Property Tax, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee.
