

## COLLECT CALLING PRODUCTS<sup>1</sup>

<b>State-to-State Collect Calling</b>	
<p>The following products allow customers to place station-to-station collect and person-to-person collect calls at reduced rates. Station-to-station collect calls are completed with the assistance of an automated voice response unit. Person-to-person collect calls will default to a Sprint operator.</p>

- All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.
- An operator dialed surcharge may apply to person-to-person calls.
- This service allows Sprint and non-Sprint customers to place Station-to-Station Collect or Person-to-Person Collect calls over the Sprint network from anywhere in the U.S. Mainland, Alaska, Hawaii, Puerto Rico, the U.S. Virgin Islands, Guam, CNMI or Canada by dialing certain Sprint-provided toll free numbers, including 1-800-663-3463, 1-800-277-7468 and 1-800-626-4537. The calls will be completed with the assistance of an automated voice response unit (VRU). Person-to-person collect calls will default to a Sprint operator. Calls are billed in one minute increments with fractional calls rounded up to the next minute.
- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee. In addition, state Universal Service Fund charges may also apply to interstate and/or international services.
