Discounted Calling Promotion ¹

Beginning January 29, 2000, Sprint will offer existing Sprint customers who subscribe to Sprint International Option A, Sprint International Option B, Sprint International Option C, , Sprint Sense International Weekend Savings, Sprint International Traveler Plus, Sprint Sense Latin Calling Plan, Sprint International Work at Home, Sprint International Option Interstate and International, Sprint General International Calling Plan, Sprint International Market Test Promotion #2, Sprint International Canada Flat Fee - \$30 Market Test Service, Sprint International Mexico Flat Fee - \$30 Market Test Service, Sprint International Canada Flat Fee - \$60 Market Test Service, Sprint International Favored Nation, Option 1 Market Test Service, Sprint International Philippines Flat Fee - \$50 Market Test Service, Sprint International Philippines Flat Fee - \$100 Market Test Service, Sprint International Threshold Market Test, Sprint International Option D, Sprint Global Family (Asia), Conexion Mundial de Sprint, Sprint Global Family, Sprint Global Family Worldwide or Sprint Global Family Connections with Nickel Nights a discounted Dial-1 rate to Argentina, Colombia, Panama, Peru, Japan, South Korea, Taiwan or Venezuela in accordance with the following: if one of these countries in either Group 1 or Group 2 below is the customer's first or second most called country each month based on total minutes of use over the past three months, the customer will receive discounted dial-1 rates for calls placed to any of the countries within the group. The discounted dial-1 rate will apply in lieu of the dial-1 rate of the customer's underlying service. The discounted rates will apply 24 hours a day, 7 days a week. The customer can receive discounted dial-1 rates to only one of the two groups below.

The customer will receive the benefit of the promotion on the customer's first partial and each full invoice thereafter for as long as the customer remains subscribed to one of the services specified in this promotion. If a customer cancels Sprint service, no promotional benefit will be given to the customer on the customer's final invoice. Instead, the base tariffed rates of the customer's underlying service will apply. This promotion available through August 31, 2000 unless sooner changed or canceled by Sprint.
