- Dial-1 long distance voice usage provided under this service offering applies on a per line basis only and does not include usage associated with: Sprint FONCARD calls; calls which are pay for use, including calls to 900, 976, 555 and 700 numbers; calls to Directory Assistance calls which involve an operator service, including emergency interrupt and intercept call completion; and toll free service.
- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee.
