

## INTERNATIONAL SERVICE INBOUND OPERATOR SERVICES<sup>1</sup>

International Service Inbound Operator Services allows customers to place Person-to-Person Collect and Person-to-Person Third Party operator services call from various countries to the U.S. Mainland, Hawaii, Puerto Rico, and the U.S. Virgin Islands. Some types of Station-to-Station calls may be made from Canada, Cuba, and Mexico. The per call surcharges below apply.

### Per Minute Rates and Per Call Surcharges

- All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute. The minimum charge for an inbound operator services call is one minute.
- All surcharges apply per call.
- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee. In addition, state Universal Service Fund charges may also apply to interstate and/or international services.
