- <sup>2</sup> This charge applies for calls terminating in Canada from the United States (excluding Hawaii, Puerto Rico, the U.S. Virgin Islands, Guam and CNMI). Calls from Hawaii, Puerto Rico, the U.S. Virgin Islands, Guam and CNMI to Canada will receive the Outbound International Per Call Charges.
- <sup>3</sup> This service is available to all Sprint served countries except Cambodia.
- <sup>4</sup> A per call surcharge will be applied by the foreign PTT.

- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee. In addition, state Universal Service Fund charges may also apply to interstate and/or international services.
