

RESIDENTIAL TOLL FREE OPTIONS*¹
(No Longer Offered)

- Residential Toll Free (RTF) service is an inward calling service. RTF Service allows calls to terminate over a customer's existing residential phone line.
- A customer who subscribed to RTF service Options A, B, C, D, E, F, or G has RTF service as an add-on to their underlying residential offering or as a stand-alone service.
- Effective August 15, 2008, Personal Identification Numbers (PINs) will be discontinued for stand-alone RTF service and RTF service combined with or added-on to a customer's residential service. Customers subscribing to such services will be given the option of subscribing to RTF service Option B, which otherwise is not available to new customers. Customers having a unique toll free number will be charged a \$1.00 monthly recurring charge.
- All RTF service calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.

- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee. In addition, state Universal Service Fund charges may also apply to interstate and/or international services.
