**SPRINT 1000 NIGHTS\***  
**(No Longer Offered)\***

- Customers that are inadvertently subscribed to a plan that is not offered in their area will be moved to the associated plan for which they qualify following 30 days' notification.
- All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.
- All call placements charges, connection fees and surcharges apply per call.
- The service was available to residential customers who have selected Sprint as their primary interexchange carrier and is only available at the customer's Associated Locations, as defined in the Terms and Conditions. The service is also available via cellular access for customers presubscribed to Sprint.
- The customer must subscribe to Sprint 1000 Nights for Dial-1 service.
- A customer's phone line may not be classified as a "business", "public" or "semi-public" line. The customer's account may not have more than one residential phone line associated with its account and each household is limited to one Sprint 1000 Nights account. A customer must have an individual residential phone line service from the local exchange company provider presubscribed to Sprint for interstate long distance service.
- The customer's phone line may not be in housing associated with educational institutions.
- If Sprint determines that the service is not being used for individual residential service, or in any other way violates the restrictions of this service, Sprint may suspend or terminate the customer's service.
- The MRC will apply each month or partial month and will be billed in advance of service, except for the initial month (or fraction thereof). The MRC for the initial month (or fraction thereof) will be billed on the customer's first invoice. Specifically, the first bill the customer receives will include a MRC for the first month (or prorated MRC for a partial month) plus the MRC for the next month's service.
- There will be no proration of the MRC for a partial month's service when a customer cancels service.
- When Sprint 1000 Nights is bundled with an intrastate offering, the free weekend minutes will be a combined intrastate/interstate 1000 minutes. An additional intrastate MRC will apply.
- In return for a higher MRC, subscribers to Sprint 1000 Nights with 7 Cents Day Rate Option will receive an interstate Dial-1 per minute day rate of \$0.07. An MRC of \$25.00 will apply.
- This service is available for use by individuals residing at a single-family residence, including but not limited to a house, condominium, or apartment, where service is being provided. This service is not available in group or multi-family housing, including but not limited to housing associated with educational institutions or military barracks.
- Use of any feature, including but not limited to call forwarding, on a planned and continuing basis to allow an originating caller to avoid long distance charges is prohibited.
- Dial-1 long distance voice usage provided under this service offering applies on a per line basis only and does not include usage associated with: FONCARD calls; calls which are pay for use, including calls to 900, 976, 555 and 700 numbers; calls to Directory Assistance calls which involve an operator service, including emergency interrupt and intercept call completion; and toll free service.
- Other surcharges and fees may apply, including (but not limited to) Carrier Cost Recovery Charge, Carrier Universal Service Charge, Frequent Flyer Excise Charge, Gross Receipts Tax Surcharge, International Mobile Termination Surcharge and Single Bill Fee. In addition, state Universal Service Fund charges may also apply to interstate and/or international services.
