- Customers who subscribe to Sprint to Home Plus LD II and subsequently cancel their wireless service will be switched to Sprint 7¢ Anytime upon customer notification.
- A customer who subscribes to this service will not be charged the Single Bill Fee.
- All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.
- All call placements charges, connection fees and surcharges apply per call.

- A customer's phone line may not be classified as a "business", "public" or "semi-public" line.
- A customer must subscribe to Sprint to Home Plus LD II for outbound Dial-1 Service.
- For each wireless number, a customer may have one Sprint to Home Plus LD II account.
- Dial-1 usage provided under this product offering does not include usage associated with: Sprint FONCARD calls; calls which are pay for use, including calls to 900, 976, 555 and 700 numbers; calls to Directory Assistance calls which involve an operator service, including emergency interrupt; and toll free service.
